It involves mild to moderate levels of physical activity, including the provision of practical assistance in household maintenance tasks and participation in various recreational activities.

- Advanced understanding of harm reduction approach and its implementation in a community-based setting
- Demonstrated ability in crisis de-escalation skills applied in a team setting
- Demonstrated ability to work with individuals who are marginalized, under-served and who may be at risk of homelessness
- Demonstrated ability working with individuals living with substance misuse issues and or an untreated mental illness
- Understanding of and experience with a trauma informed approach to community mental health services
- Ability to establish and maintain therapeutic rapport
- A sound understanding of the issues related to meeting basic needs and the long-term impact of institutionalization
- Ability to work effectively, independently and in cooperation with others.
- Ability to communicate effectively, both verbally and in writing.
- Ability to observe and recognize changes in client's level of functioning
- Demonstrated ability to create and facilitate therapeutic group experiences
- Experience in assessing individual capacity regarding decision-making
- Demonstrated ability to promote and support individual recovery
